By completing and submitting this rebate agreement form to the Michigan Education Association ("MEA"), you ("Member") agree as follows:

1. Member certifies that he/she paid his/her MEA, National Education Association ("NEA"), MEA local affiliate, and any other applicable dues in full for the 2020-2021 MEA fiscal year on or before October 30, 2020 or on or before any applicable earlier date that may be established by the locally billed MEA local affiliate. Under no circumstances may the locally billed MEA local affiliate establish a date for the payment of dues in full under the dues rebate program that is after October 30, 2020. By completing and signing this form, Member is requesting to participate in and receive a \$30 rebate under the MEA dues rebate program.
2. This rebate agreement form must be signed and dated by Member and returned to the local affiliate by the date established by the local affiliate.
3. Failure to sign and date this form and return it to the local affiliate within the timeline established by the local affiliate or to meet any of the requirements of the dues rebate program shall render Member ineligible for the \$30 rebate regardless of any payment of dues. Failure of the locally billed MEA local affiliate president to sign and date this form and return it to the MEA address listed below within the timeline outlined herein or to meet any of the requirements of the dues rebate program shall render Member ineligible for the \$30 rebate regardless of any payment of dues.
4. Members in arrears, members on a leave/layoff, and nonmembers are not eligible for the dues rebate program or any rebate.
5. MEA reserves the right in its sole discretion to determine whether Member is eligible for the dues rebate program and the rebate referenced herein. MEA's determination is not subject to challenge in law, equity, or through the internal processes of MEA or NEA.
6. MEA reserves the right to pass along to the Member any fees associated with voiding or reissuing rebate checks to Member.
7. Member agrees that the \$30 rebate will be issued by MEA by check (or other form of remuneration) within 90 days of the submission of the rebate agreement form if the conditions outlined herein are met.
8. As a condition of participation in the dues rebate program, Member agrees to financially support MEA, NEA, MEA local affiliate, and any other applicable entity by paying an amount equal to membership dues for the 2020-2021 MEA membership year as established by the Representative Assembly of the MEA and the NEA, and by the local governance procedure irrespective of his/her actual membership status. If any provision of this rebate agreement form is found by a court to be invalid, unenforceable or unlawful, in whole or in part, then the provision shall be construed in a manner necessary to render the provision valid and enforceable. All other provisions shall be unaffected and remain enforceable.
11. Member acknowledges reading this rebate agreement form, understanding its terms, and entering into this agreement voluntarily. At his/her own expense, Member has the right to consult with counsel prior to signing this rebate agreement form. Member acknowledges that he/she has not been subject to any duress, intimidation, threats, or coercion in the execution of this rebate agreement form or regarding any of the matters covered herein.
