I understand that I am making a joint contribution to the NEA Fund for Children and Public Education and the Michigan Education Association PAC and my contribution will be allocated between them as have instructed. Contributions or gifts to The NEA Fund for Children and Public Education and the MEA-PAC are not deductible as charitable contributions for federal income tax purposes. Federal law requires us to use our best efforts to collect the name, mailing address, occupation and the name of employer of individuals whose contributions aggregate in excess of \$200 in a calendar year. Federal law prohibits The NEA Fund for Children and Public Education from receiving donations from persons other than members of the NEA and its affiliates and their immediate families. All donations from persons other than members of the NEA and its affiliates and their immediate families will be returned forthwith.
